Responsibilities

The Climate Expert will be responsible for executing climate-related consulting projects in close alignment with the team lead and client stakeholders. You will help clients understand their carbon footprint, agree goals and develop action plans to help decarbonize their business. In doing so, you will own analyses with an eye for detail but never forget to deduce strategic implications. Projects will typically center around:

- **GHG emissions inventory and analysis** – You'll track energy and GHG emissions data, calculate corporate carbon footprints (scope 1-3) and provide analytical insight into the emission profile
- **GHG Goal Setting** – You'll help clients develop ambitious but realistic carbon reduction goals, often as part of a wider sustainability strategy discussion. You'll help identify carbon reduction opportunities and build out climate action plans to achieve GHG goals.
- **Climate Risk Assessment** – You'll assess corporate climate risk, including through scenario analyses, deduce risk mitigation actions and enable clients to report in line with the TCFD recommendations
- **CDP and Sustainability Reporting** – You'll complete CDP questionnaires and use the insights from the process to help elevate the client's carbon management. You'll also support wider sustainability reporting efforts, many of which include disclosure of GHG management approaches and data
- **Practice Development** – You'll evolve our service offering and internal tools in line with client needs, regulatory expectations and wider industry trends
